## Keeping you informed

Along with other members of our community, many of Westerham's Town Councillors viewed the 'Which Way Westerham – the emerging masterplan' exhibition on 26 – 27 January.

The exhibition provided a little more detail on that published last year but the evidence on which many of the statements were based was not clear. In particular, the financing of the plan, its dependence on the restoration of Covers Farm and the involvement apparently needed from other organisations were not clear. The Council will be seeking much greater clarity on the plan.

While it continues to investigate these issues, **Westerham residents can be assured that its Council will continue to represent their views**, expressed in last October's survey, when 86% of the 700+ households who responded, opposed the WWW concept, a response rate and result which was echoed in the wider survey conducted by SDC.

The Council encourages all those in Westerham to find out as much as they can about Squerryes' proposal, so that when they are asked again for their views – as they will be when the detailed masterplan is submitted to SDC and/or when the draft local plan is issued by SDC they are confident in expressing their opinion.

For its part, the Council plans to hold further public meetings when it has answers to some of the questions raised above. Certainly this will be a key topic at the **Annual Town Meeting to be held on 18 April at 7.30pm in Westerham Hall** when our District and County Councillors will be attending.

## Westerham Town Council CIL (Community Infrastructure Levy)

Westerham Town Council has now received from Sevenoaks District Council the Community Infrastructure Levy (CIL) money arising from the developments on Canville Rise, off London Road, and in Croft Road. This payment amounts to £157,411.56.

There are very strict legal restrictions on the types of projects on which CIL money can be spent. However the Council is pleased to say that several of the projects identified by residents in the major consultation held in 2016 can be paid for with the help of CIL money.



**Mobile CCTV:** with the current – and sadly recurring – episodes of vandalism, your Council has bought a mobile CCTV unit. Able to be moved to different locations in the town, we hope that this will deter those intent on causing damage, or if they persist, we will be able to identify them.

**Fullers Hill public toilets:** on two occasions residents have been asked whether these are essential facilities for the town and on both occasions the answer has been a resounding 'yes'. So work will soon be going ahead to replace the current toilets.

**Parking: Costells Meadow car park and additional spaces in Madan and Hartley roads.** The Council is funding the design work for this project. The construction work needed to provide the extra spaces should be funded through CIL.

Once we have full costings of these projects – we'll be able to see what else our CIL money might fund.

### **Sevenoaks District Council survey**

#### **How does the cost of housing affect employees and local businesses?**

We are keen to hear from people who live and work locally about their views on the cost of housing.

Sevenoaks District is the most expensive place to live in the whole of Kent. The cost of buying a local home is now 13 times the average income and the District's house prices are comparable with many parts of London. This means buying or renting a home is unaffordable for many younger people setting out on a career and those on modest incomes.

High house prices could impact on essential services such as teaching and the emergency services, as well as many other services we take for granted such as retail, high street services and even care homes.

We are running a Local Employees Survey to help us understand how the cost of housing affects where people are able to live and work and how this affects businesses in recruiting and retaining staff now and in the future. The data from the survey will help us draw up new housing policies. If evidence points toward a problem, we could include a policy to provide more affordable homes specifically for local workers.
