Internal alterations. Air Source Heat Pump.

WTC supports the application subject to an agreed Construction Management Plan due to the single-track access with only a few passing places, which details the following: -

- restriction on the weight and width of vehicles using New Road
- routing of vehicles to the Site
- employee parking
- delivery vehicle unloading and turning
- wheel washing
- any requirements for traffic management
- any necessary repairs to New Road caused by construction vehicles to be the responsibility of the applicant.

The Committee had concerns regarding the safety of vehicles exiting onto Main Road. New Road is used by pedestrians, walkers etc. and twice a day by those walking to and from Crockham Hill C of E Primary School. The School also has a Forest School which is accessed by young people walking to and from the site along New Road.
